


Notes:

Beginning as on 1st April, 2017, the Company has first time adopted Ind AS with a transition date of 1st April, 2016.

TO THE BOARD OF DIRECTORS ACROW INDIA LIMITED,

1. We have reviewed the accompanying statement of unaudited financial results of M/s. **ACROW INDIA LIMITED** ("the Company") for the quarter ended June 30, 2022 (herein after referred to as "the Statement"), attached herewith. The statement is being submitted by the Company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, (the Regulations) as amended.
